CAMP MOSHAVA CAMPER REGISTRATION CONTRACT

Camp Moshava has many policies instituted to help each camper derive as much as possible from his or her camping experience. A copy of the Camp's rules and regulations are available upon request. Your signature to this agreement indicates your desire to abide by the Camp's rules and regulations. I understand that part of the camping experience involves activities, group living arrangements and interactions that may be new to my child. These things come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by the camp's rules. My child and I both agree that he or she is familiar with these rules and will obey them.

We hereby enclose a payment in the amount of \$200 (\$250 for non-Moshava Ba'ir campers) per child which includes a \$50 non-refundable registration fee. The payment minus the deposit will be refunded if written notice of cancellation is received by May 1. We agree that there will be no deductions from the fee of a camper arriving later or leaving early, nor will there be any refund for cancellations after May 1. Camp Moshava, reserves the right to, in its sole discretion, remove any camper for reasons it believes are in the best interests of its camping community. Should a camper be sent home for disciplinary reasons, no refund will be made. If this application is rejected for any reason, the full payment will be refunded. The parent or guardian authorizes Camp Moshava to use pictures or videos of the camper for promotional purposes.

Camp Moshava reserves the right to cancel any program or group for any reason. In the event of such cancellations, a refund for that part of the cancelled program will be made. It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in the PA Court of Common Pleas located in Wayne County, PA and shall be construed in accordance with the laws of the State of PA.

In the event of divorce, parental separation, or other custody issues, in order to maximize your child's camp experience, it is our firm policy NOT to become embroiled in any disputes. We will therefore follow the wishes of the parent that signs the enrollment form in deciding who may have contact with the child, including phone contact, who may remove the child from the campus and who may have access to the child's files and records. Any such instructions should be provided to us, in writing, by the parent who signs the enrollment form. If no such instructions are provided, we will assume that both parents have full access. If both parents sign, then each will have the same rights in this regard. Similarly, the parent (or parents) who sign the enrollment form remains financially responsible to the camp for any obligations resulting from the child's stay at camp, including but not limited to tuition, and regardless of any private arrangements between the parents.

In case of an emergency, Camp Moshava is hereby granted permission to secure any medical and/or surgical treatment and hospital service for the camper upon the advice and recommendation of our camp medical staff. We further authorize the camp medical staff to discuss any medical conditions with the director, his/her designee, or the child's counselor when the medical staff, in its sole discretion, believes such communication is in the best interest of the child.
